## 19.2. Composition of Committee

- (a) The Committee shall include:
  - (i) Chairperson
  - (ii) Vice-Chairperson
  - (iii) Secretary
  - (iv) Treasurer,

(collectively called the Office Bearers), and

(v) not less than two (2) or more than four (4) other persons, all of whom must be members of the association

Following the election of Management Committee, the current number of elected committee members is five, therefore a minimum of one person is required to be constitutionally compliant.

In accordance with the Boyup Brook Community Resource Centre Constitution Clause (8): If a vacancy remains on the Committee after the application of sub-rule (7), or when a casual vacancy within the meaning of rule 14 occurs in the membership of the Committee:

- (a) The Committee may appoint a member to fill that vacancy; and
- (b) A member appointed under this sub-rule will:
  - (i) Hold office until the election referred to in sub-rule (2); and
  - (ii) Be eligible for election to membership of the Committee, at the next following annual general meeting.
